TRIP INFORMATION & BRIEF SCHEDULE

- **REGISTRATION/TRIP COSTS: \$150.00 per passenger** (no meals included; bring extra spending money). Your ticket, a detailed schedule, and further information about what to bring will be mailed to you after full payment is made and both pages of the reservation form are completed and received.
- **DUE BY: All reservations must be received by January 7, 2009.** Reservations will not be confirmed until payment & registration form are received. Please get your reservations in early to get seats on your preferred bus!
- **LOCATIONS: Buses available from several pick-up points in the St. Louis metro area.** Please see page 2 of the application form to select a bus. **REMINDER:** Some buses fill up very quickly! Buses loading at locations other than the Arch may have different schedules. If you want to coordinate a bus of your own (must be a group of at least 42 people; you decide the pickup & drop off location), please call MRL, Eastern

Region Office at (314) 434-4900.

- **AGE LIMITS:** Please Note: Due to confined space on the buses, uncertain weather conditions & keeping with our desire to always protect children born & unborn, children under age 7 are prohibited from making the trip. For every four youths (7-18 years old) going on the Missouri Life Caravan, we require at least one responsible adult chaperon to accompany them on the trip. Missouri Life Caravan does not provide chaperons.
- **SCHEDULE** (Further instructions and information will be given out on the buses. Schedule subject to change.)
Wednesday, January 21, 2009 For buses boarding at locations *other than the Gateway Arch*, boarding begins approximately 7:00AM and those buses then meet the others at the Arch for the following schedule: **AT THE GATEWAY ARCH IN DOWNTOWN ST. LOUIS:** 8:00AM - Check in on your bus; 9:00AM - Get off your bus with your signs for the Prayer Rally & Press Conference on the riverfront platform; 9:30AM - Board buses & depart for Washington, DC.
Thursday January 22, 2009 7:00AM - Arrive in Washington, DC near Union Station; proceed to morning "Big Meeting" to hear Politicians & Speakers. 12:00PM - National March for Life & Rally near Washington Monument, & afternoon appointments with Senators & Representatives. 7:30PM - Board buses & depart from Union Station in Washington, DC.
Friday, January 23, 2009 Approximately 2:00-4:00PM - Arrive in St. Louis area and other locations. Home!
